Categories

The award will be in the following categories:

- a. **Large Enterprise**
(Organizations with annual turnover of more than 250 crores)
- b. **Medium Enterprise**
(Organizations with annual turnover of more than 75 crores but less than 250 crores)
- c. **Small Scale Enterprise**
(Organizations with annual turnover of more than 5 Cr but less than 75 crores)
- d. **Recognition of Professional Excellence (Individual)** – *Organisations nominating for 2 projects/units at the ICC OHS Awards 2022 are eligible to nominate one deserving candidate and those nominating 3 or more projects/units are eligible to nominate two deserving candidates for the Recognition of Professional Excellence.**Please refer to **Annexure -2** for Application Form.*

Levels of Recognition:

There are three levels of recognition for each category. These levels signify the various milestones, which the organisations can aim for as they progress on their journey towards excellence. Therefore, the organisations at different level of competitiveness can benefit from participating in the award process.

Award Process:

Application in the given format → initial assessment of the application → Short listing of applicants for the Jury presentation → jury visit to select units / work places /properties → Final Jury Meeting & Selection of the winners.

Application Fees:

The fee for processing the application is as follows:

- Large Enterprise & Medium : **Rs 25000/- + 18% GST**
- Medium Enterprise : **Rs 20000/- + 18% GST**
- Small ScaleEnterprises : **Rs.15000/- + 18% GST**

The fee should accompany the application, in the form of a demand draft / cheque at par, favouring“**Indian Chamber of Commerce**”
